## Description: Top Drive Inspection Schedule Modification

## BACKGROUND INFORMATION:

In order to provide customers with increased drilling time between mandatory re-certifications, TESCO has developed a new inspection program. This new program uses a series of field inspections as a means of monitoring the health of the top drive between full mandatory re-certifications. This will permit an extension of the re-certification interval from 500 to 1,000 operating days. The new inspection program incorporates a series of mandatory field based inspections at 250, 500 and 750 days. The field inspection intervals are based on historical operating data and are designed to meet the recommendations of TESCO engineering and OEM non-destructive testing and maintenance guidelines.

Please note that this new inspection schedule is to be used for normal drilling and is not intended to replace the extra inspections that are required following rough drilling and jarring.

The following table provides the part number for the re-certification documents to be used in this new inspection program. There is also an overview document (doc # 882055 Rev 0) available that describes the importance of the inspection program and provides instructions for field technicians.

## AFFECTED PRODUCT:

This change is applicable to all TESCO electric and hydraulic top drive systems.

## ACTION REQUIRED:

The user should determine the total number of operating days on the unit at this time and use the following guide to determine the course of action to initiate the new inspection procedure:

- For operating days less than 250 wait until 250 days and complete 250 day field inspection.
- For operating days greater than 250, but less that 400 immediately perform a 250 day field inspection.
- For operating days greater than 400, but less than 600 immediately perform a 500 day field inspection.
- For operating days greater than 600 immediately perform a full 1,000 day re-certification.

Once the initial inspection or re-certification has been completed the 250, 500, 750 and 1,000 day program can be followed as per usual.
